This agreement is for PWG to supply a vendor space and/or table at the show listed above and to provide bridal show leads following the show. Company listed above agrees to abide by all rules of the bridal show including, but not limited to, those imposed by the host venue. Company also agrees that any leads obtained from the show are not to be sold, traded, given or otherwise disseminated to any other business or individual. Leads may not be used to promote any other bridal show (even if you're a participant) without written permission of PWG. Company agrees that misuse of leads would cause PWG irreparable harm. Therefore, company agrees to pay PWG \$1,500. for each unauthorized use of leads and agree that such an amount is not a penalty. Cancellation of this agreement by said company less than 45 days prior to show date will result in full amount due. No refunds shall be given if cancelling 45 days or less prior to show date. PWG may, at its option, allow credit to be moved to another show date. Sharing of booth space is not permitted under any circumstances. You further agree that the day-of-show instructions that will be e mailed to you at the e mail address you provided above, prior to the show, will be acceptance of all terms as outlined in the bridal show vendor e mail along with this agreement.

A door prize with a retail value of \$50. minimum is required to participate in this show. You keep the door prize at your vendor booth until claimed by a bride. If the prize is unclaimed, you can contact the bride later from the leads list or save it for another show. The door prize must be an actual prize that is non-conditional in nature. In other words, a discount on your service or money off a product is not a prize. The prize must be offered free and clear to the winner. An additional fee of \$50. will be charged if you do not provide a door prize to be given away.
